The principles of Good Clinical Practice (GCP) have their origin in the World Medical Association's Declaration of Helsinki. The Declaration of Helsinki was responsive to the revelations of the Nuremberg trials conducted after World War II, and its drafters sought to ensure that human subjects involved in clinical research would, in future, have their rights, safety and well-being placed above all other considerations in clinical research. The document has been revised several times since it was first published in 1964.

Study 2: Myung-Guk Han et al. "Identification of Coronavirus Isolated from a Patient in Korea with COVID-19", Osong Public Health and Research Perspectives, February 2020 [Pubmed ncbi] (7) **Replying Author:** Myung-Guk Han Date: May 6, 2020 **Answer:** "We could not estimate the degree of purification because we do not purify and concentrate the virus cultured in cells."

Study 3: Wan Beom Park et al. "Virus Isolation from the First Patient with SARS-CoV-2 in Korea", Journal of Korean Medical Science, February 24, 2020 [Pubmed ncbi] (8) **Replying Author:** Wan Beom Park Date: March 19, 2020 **Answer:** "We did not obtain an electron micrograph showing the degree of purification."

Study 4: Na Zhu et al., "A Novel Coronavirus from Patients with Pneumonia in China", 2019, New England Journal of Medicine, February 20, 2020 [nejm] (9) **Replying Author:** Wenjie Tan Date: March 18, 2020 **Answer:** "We show an image of sedimented virus particles, not purified ones."

In the Australian Government's Immunisation Handbook under Section 2.1.3 Valid Consent, it states that for consent to be legally valid "It must be given voluntarily in the absence of undue pressure, coercion or manipulation."
